This cost-saving service is for multiple package shipments going to the same recipient on the same day. Packages are rated individually and as one shipment. **You pay the lower rate!** Plus, free inside delivery.

- Applicable for zones 2-8.
- Minimum shipment weight is 200 lbs.
- Minimum average package weight is 15 lbs.
- Rated shipment weight 200-499 lbs. Tier 6.
- Rated shipment weight 500+ lbs. Tier 506.

FedEx Home Delivery is a residential-only service for businesses that ship packages to homes. This service allows customers to choose from three different delivery options (FedEx Date Certain Home Delivery®, FedEx Evening Home Delivery® or FedEx Appointment Home Delivery®).

Discounts on Continental U.S. Outbound Prepaid, & Third Party Billing

- A **5%** discount on packages weighing 1-20 lbs.
- A **10%** discount on packages weighing 21-70 lbs.
