### Shipper Agreement

#### FedEx Terms & Conditions of Shipping

- The prices and other terms and conditions provided to you as a Shipper are for your exclusive use and benefit and are to be treated as confidential information. The prices (or any portion thereof) may not be extended to any other party. You may not under any circumstances sell, assign, or otherwise transfer (including but not limited to, third party billing) the benefit of this pricing to anyone. Failure to abide by this provision may result in immediate termination of your participation in the Program. With the exception of custom freight pricing agreements between FedEx and Shipper, this Agreement supersedes all Pricing Agreements and Addenda, if any, for express services between FedEx and Shipper for the designated U.S. Payor account numbers relating to the services and package types covered by this Agreement.
- Association and/or its agent may receive compensation for the promotion of FedEx services. In addition, you specifically acknowledge and agree to the release of your shipping information and data to Association and/or its agent.
- Member's rates are expressed as a percentage discount off published shipping rates in effect at the time of shipment. Published rates are subject to change without notice.
- Accessorial charges, special handling charges, and surcharges shall be in accordance with the FedEx Service Guide in effect the date of shipment for the service selected.
- You must complete this enrollment form to participate in the Program.
- Each shipment made under this Agreement is subject to the terms and conditions of the FedEx Service Guide in effect at the time of shipment and which terms are incorporated into the Agreement by reference. FedEx reserves the right to modify the FedEx Service Guide at any time without notice.
- Participation in the Program is conditional upon obtaining FedEx credit approval. FedEx reserves the right to deny credit and we do not extend consumer credit privileges.
- Payment on your account is due fifteen (15) days from the invoice date. Duties and taxes are payable on receipt. Failure to comply with our payment terms may result in denial of credit and removal of discounts.
- This Program will be effective for so long as the Incentive Pricing Addendum remains in effect with PartnerShip LLC, or until termination of that Addendum, whichever first occurs. However, FedEx or Shipper may terminate this Agreement in its entirety at any time upon thirty (30) days written notice to the other.
- Shippers are prohibited from using the FedEx name or logo without the prior written consent of FedEx.
- A federal excise tax when required by the Internal Revenue Code on the air transportation portion of any FedEx service, if any, is paid by FedEx.
